SEBI/HO/ DDHS/P/CIR/2021/613 dated August 10, 2021 (earlier SEBI circular SEBI/HO/DDHS/CIR/P/2018/144 dated November 26, 2018), issued by Securities and Exchange Board of India ("SEBI") and BSE circular bearing reference no. 20220427-2 dated April 27, 2022, in respect of fund raising by issuance of debt securities by large entities.

In this regard, kindly note that as per the applicability criteria given under the Clause 1.2 of Chapter XII of Operational Circular bearing reference no. SEBI/HO/DDHS/P/CIR/2021/613 dated August 10, 2021, Data Infrastructure Trust (formerly known as Tower Infrastructure Trust) ("Trust") does not fall under the Large Corporate category as on March 31, 2022.

Further, the Trust has not issued any specified securities or debt securities or non-convertible redeemable preference share in terms of Securities and Exchange Board of India (Listing Obligation and Disclosure Requirements) Regulations, 2015 during the financial year 2021-22 and does not have any outstanding borrowing as on March 31, 2022.
